- 1. Treasurer Report Balance as of today's meeting: \$439,187.16
- 2. Selma Fire Department update on CPR classes CPR Class to be held 4-26-2025. Class is full. A \$20.00 deposit is required to secure a spot in the class and this deposit is refunded to the student as soon as they come to the class.
- 3. Selma Fire Department update on Lucas Devices Lucas Devices were recently purchased and installed in the emergency vehicles. The board was able to see the devices and where they were kept. More info will be brought to next regular meeting
- 4. Adventist Health Quarterly Update on Mental Health Initiative Atalie Rosales from the AH grant department gave a very positive report on the mental health initiative. There have been 672 therapy appointment scheduled, 488 kept appointments. The no-show rate is 18.9% which is down from 32% before the program was initiated.
